As indicated in P.C.C.F's report proposed chargesheet and action against Dr. Nand Kishor is based only on the misappropriation committed by one accountant at Gandia Forest division. whereas, it is settled principle of law that only on the basis of misappropriation committed by subordinate without common object, intention or knowledge superior, superior cannot be held responsible.
3. In the said case there is no direct or indirect evidence by which it can be proved that

The PCCF was requested to submit the authenticated documents regarding the proposal submitted by him. The documents submitted by him contained only the audit report of audit party of his office carried out during 1991 along with the documents collected by the audit party and some correspondence regarding the follow up action taken by the PCCF's office to avoid recurrence of the irregularities observed in the audit. These documents show that fixing of responsibility for the said irregularity was considered at that time and only after that the accountant appears to have been charge sheeted. These documents also show that police case also lodged against him. There are no documents to show as to how the PCCF came to the conclusion regarding the collusion of Dr. Nand Kishore in this case.

2. The PCCF was, therefore, specifically requested vide Government letter dated 2-8-2002 and 1-9-2002 to submit the documents related to the complaints mentioned in his letter, report of the inquiry of the complaint and the documents related to the departmental proceedings against the accountant. But he has not submitted any of these documents.

3. In an the anonymous complaint the copy of the charge sheet proposed against Dr. Nand Kishore has been enclosed showing that some outsiders are privy to
